Privacy and cookie statement - General Data Protection Regulation (GDPR)

We are aware that you place your trust in us. The privacy of visitors is protected by Roton Lifts Europe respected and treated confidentially. In this privacy and cookie statement we inform you about privacy-sensitive aspects of our services and website. This privacy and cookie policy applies to the website www.rotonlifts.eu.

We process personal data in accordance with the General Data Protection Regulation (GDPR). In this statement, Roton Lifts Europe explains which personal data Roton Lifts Europe uses and for what purpose. By using this website you indicate that you have read and accepted our privacy and cookie statement.

Processing personal data

We process your personal data in two different ways. We make a distinction between personal data that you actively provide to us via the contact form on the website and personal data that is automatically provided to us, transmitted by cookies. When you want to contact Roton Lifts Europe via the contact form (or other forms), Roton Lifts Europe asks you to provide your personal data. This personal data is stored in the customer system of Roton Lifts Europe.

Processing purposes

This data is used in the context of our services or your website use. The data is stored on secure servers or those of a third party. The personal data that we process from you will only be used for the following purposes:

- for the performance of the services offered;
- to get in touch with you;
- analysing and improving our services;
- delivery and billing of our products, in fulfilment of your request.

Cookies

We use cookies on our website. Cookies are small text files that are placed on your computer. We use cookies to measure internet behaviour (click behaviour) and analyse visitors to improve our services and website use. Most browsers are set to accept cookies by default, but you can change your browser settings in order to refuse all cookies or to

indicate when a cookie expires. However, some features and services on our and other websites may not function properly if cookies are disabled in your browser.
